1. Accept RFT02-2425 tender submission received from Green Wave Solar Pty Ltd for the:
 - a) supply and installation of electrical upgrades, 100kW solar and BESS to the Bridgetown Leisure Centre (BLC), and;
 - b) supply and installation of 20kW of additional Solar to the Bridgetown Library, and;
 - c) supply and installation of 30kW of solar and BESS to the Bridgetown Civic Centre, and;
 - d) supply and installation of 10kW of solar and BESS to the Bridgetown Incident Control Centre.
2. Authorise the CEO to:

-
- a) negotiate and agree minor variations with the recommended respondent; and
 - b) enter into a financial contract with Green Wave Solar Pty Ltd for the sum of \$340,466.60 plus GST to supply and install items a-d above; and
 - c) utilise funds from GL 1346140 TF06 Recreation & Culture Buildings Solar Panels & Batteries as needed; and
 - d) expend additional funds (to be allocated against GL 1346140 TF06 Recreation & Culture Buildings Solar Panels & Batteries) up to a maximum of \$30,000 to provide project contingency.
3. Consider a budget amendment in the Council's March Budget review, to increase GL 1346140 should the project costs including contingency, exceed the current budgeted amount.
